

- Utilizing the expertise of policymakers and advocacy groups to shape inclusive dementia care policies in India.


HIGHLIGHTS

INAUGURATION

The Inaugural Ceremony of DemCon'24: International Conference on Dementia Care – Reaching the Unreached was held at the JN Tata Auditorium, IISc, Bangalore. The keynote address was delivered by Shri Graeme Prior, President of the International Federation of Ageing, who highlighted global challenges and innovations in dementia care. Recommendations on Dementia Care Standards were submitted, outlining key strategies for improving care practices. Guest of Honour Dr. Rajinder K Dhamija addressed the integration of dementia care into public health policies, while Chief Guest Shri Dinesh Gundu Rao, Hon'ble Minister of Health and Family Welfare, Karnataka, underscored the government's commitment to strengthening dementia support systems.



VALEDICTORY

The Valedictory Ceremony brought the conference to a close with reflections on its success and outcomes. A highlight of the session was the release of the Commonwealth Report by Shri Andrew Larpent, which offered valuable insights into dementia care practices across Commonwealth nations. Guest of Honour Dr. Pratima Murthy, Director of NIMHANS, emphasized the need for a multi-disciplinary approach to dementia care, focusing on its mental health aspects. Chief Guest Shri Prathap Rao Jadhav, Hon'ble Minister of State, Ministry of Ayush and Ministry of Health and Family Welfare, reaffirmed the government's dedication to advancing dementia care policies and integrating them into the national healthcare framework through the video message.

The ceremonies set the stage and concluded the conference on a high note, reinforcing the importance of collaboration among policymakers, healthcare professionals, and caregivers to address the unmet needs of persons with dementia and their families.



OUTCOMES

- 1. Dementia India Alliance (DIA) and the Institute of Human Behavioural and Allied Sciences (IHBAS) signed a Memorandum of Understanding (MoU) to collaborate on academic, outreach, and research initiatives in dementia care. This partnership aims to enhance geriatric care through clinical outreach, training programs, advocacy, and joint research efforts to improve the quality of life for persons with dementia and their caregivers.
- 2. Dementia India Alliance (DIA) and CommonAge signed a Letter of Intent (LOI) to establish a collaborative partnership in promoting healthy ageing and dementia care. This sets a framework for joint initiatives in training, advocacy, knowledge sharing, and community awareness, aiming to improve the quality of life for older adults. Both organizations committed to leveraging their expertise to co-develop resources, organize events, and advocate for policies supporting ageing populations and dementia care systems.
- 3. Letter of Intent Signed between Alzheimer's WA and DIA in the areas of capacity building, dementia care service audits and co-creation of resources.
- 4. Dementia India Alliance (DIA) and GreenXt Technology Solutions (Future Proof) signed an Indication of Interest (IOI) to collaborate in raising awareness, enhancing caregiver knowledge, and improving the quality of dementia caregiving through micro-training.
